Dear prospective member,

In accordance with Home Office regulations, we must obtain accreditation from the Tutor of any person seeking to join either the above Association or the above Club; we should be grateful if you would ask your tutor to complete the relevant section over the page. You must declare that you are not prohibited from membership of a shooting club or from the possession of firearms / ammunition, as dictated by the 1968 Firearms Act (and as subsequently amended), and (though this is not necessarily a disqualification from shooting) whether or not you have ever had a firearms or shotgun certificate revoked, or an application for such a certificate refused. You should also be aware that current legislation requires CURA and CUSBC to inform the police of the name and address of anyone who applies for membership.

⇒ *The 1968 Firearms Act, section 21, states that you may not at any time have a firearm or ammunition or fire a firearm in a club situation if: (i) you have ever been sentenced to preventive detention, or imprisonment or to corrective training for a term of three years or more, or (ii) have been in borstal training, corrective training for less than three years, or in prison for a term of between three months and three years, and are within five years of your release. The above includes any such sentence which was suspended.*
